Mr. Lennon inquired about how long we are going to sustain full employment and that we need to evaluate what we are going to do moving forward. Mr. Morgan stated that being government employees we are required to follow the rules and the laws, looking into the FFCRA policy and how that also affects what we look at doing. Mr. Lennon stated that if this drags out we need to get a step by step game plan together, what the options are and what we need to do. Mr. Lennon noted that he hoped we are not bringing any new employees on unless it is necessary, along with spending being halted, including any major projects, that he is hesitant to commit to anything right now. Chief Rowan noted that the Sherriff's Office has open positions that are not being filled at this time. There was a brief discussion about any employees retiring, but none that are recent.

HEALTH COMMISSIONER THOMAS QUADE PROVIDED UPDATE ON COVID-19

Health Commissioner Tom Quade explained that as of the end of the day yesterday there were 40 cases in Geauga County and right now have no deaths. Mr. Quade explained that at the State level the number of deaths to confirmed cases is about 2.3%, and with only testing the very sick it is not comprehensive. Mr. Quade we are still facing something, we don't know when, if you look at the great flu pandemic from 100 years ago, the first wave wasn't what took everyone out, it was the second wave when they thought it was done. It's a cautionary tale, this has been tough to get people to stay home, as they are not staying home comfortably, we need to do what we can to keep people home. Mr. Quade said they are working with the Amish community, and while there is an appearance, but so are packed parking lots at stores. Mr. Quade thanked all the departments for the cooperation. Mr. Lennon thanked Mr. Quade for being here, and that he has done a good job for leading us through this. Mr. Quade expressed appreciation for his staff that is working around the clock on this.

Local resident Diane Jones asked how much bed space was devoted at UH Hospital to COVID, to which Mr. Quade stated that is a better question for Mr. Peterson from DES, but that we are in a much better position than Cuyahoga County, adding that we are sharing more than a border with them. The number of cases is not being put out by zip code because the cases are not being caught at home, they are getting it elsewhere and then returning to home. There was a brief discussion about the early case that was miss-noted in Geauga that was from another County. Mr. Lennon inquired about the meeting today and his opinion and whether this is adequate. Mr. Lennon noted that we have business to do, but we still need to sign documents. Mr. Quade expressed that this is a fantastic photo op if you have to hold a meeting, the spacing is great, but continue to encourage the numbers being limited to how many you let in. Mr. Quade added that

you just need to continue to keep washing your hands. Human Resources Administrator Kathy Hostutler inquired about the people that are being told to stay home that are not being tested, is the Health Department being made aware of them. Mr. Quade stated no, that there is a big challenge with the numbers because of the limited testing. Mr. Quade stated that if we had enough tests, they would be ordered, we only know the positive tests that are being reported. Right now there is a big stay at home order that means that you should be staying home unless you need to live, go do it, self-quarantine is the same thing as a stay at home order. Anyone who is symptomatic of anything right now needs to stay home, and any employee must be symptom free for 3 days before they can come back. You don't want anything coming into the office, as there is a GI symptom associated with the virus. As we move through this we are learning more about the virus. If you receive a letter from me, you are being ordered to be quarantined and must stay home except for medical care. Mr. Quade stated that it is hard to report recovery when you don't know who has it, but they are going to start reporting a lift of quarantine. The research is unclear on whether someone is not contagious even if they move past the fourteen days. It is a reportable disease, but only the positive tests are what are being reported, so it's not really representative. Mr. Lennon inquired about Cleveland, to which Mr. Quade stated that if a healthcare worker is asymptomatic they are reporting to do the need for care workers, but it is a system under stress.

<u>COMMISSIONERS' OFFICE – CANCEL SESSION FOR TUESDAY, APRIL 14, 2020</u> Mr. Lennon expressed that if something comes up that needs to be addressed, he feels comfortable with this. Mr. Dvorak agreed that every other week is good right now.
