# <u>COMMISSIONERS OFFICE - COUNTY ADMINISTRATOR'S REPORT</u>

County Administrator Gerard Morgan reported on the items approved by the County Administrator on June 15, 2021 for the Airport Authority to approve the request for Partial Payment #1 for Hummel Construction for the T-Hangar project in the amount of \$45,999.95 and June 17, 2021 for the Department on Aging to approve hiring Laura Fay to the position of Full-time Recreation and Education Assistant (#1005) to be effective June 28, 2021 at the rate of \$14.83 per hour with a one-year probationary period. This offer of employment is contingent upon the successful completion of the required pre-employment conditions and for Transit approved an unpaid personal leave of absence for David Lair, Jr., Operations Manager for up to sixteen hours during the period June 17, 2021 through June 21, 2021. This will extend his probationary period by the number of hours used; as authorized by Resolution #21-003 under the direction and supervision of the County Commissioners that was approved January 5, 2021 pursuant to O.R.C. 305.30.

Budget and Finance Manager Adrian Gorton explained the financials for today as including A Cash advance out of the General Fund to the Law Enforcement Block Grant for additional money needed to purchase MDT's which will be paid back when the funds are received from the State; a Cash transfer out of the General Fund to the Airport Construction Fund for the final grant match on the runway lighting and safety improvement project; Travel requests for the County Engineer's Office and the Juvenile Court; a Contract PO for Transit to Mohawk Resources LTD for a new bus which will be reimbursed to the department from the State; a payment for the Commissioner's Office to the Portage Geauga Juvenile Detention Center for third quarter operations in the amount of \$119,332.25, a payment for the Commissioners' Office to the Airport Authority for pay request #1 for the T-Hangar construction project and loan in the amount of \$45,999.95, a payment for Transit to the Treasurer State of Ohio for their share of a new bus in the amount of \$44,057.00 and a Revenue Certification for the Common Pleas Court in the Pre-trial Release Supervision fund for additional revenue received.

#### **BUDGET COMMISSION**

Prosecutor Jim Flaiz explained that there is a statutory formula to divide the undivided local government funds and that was adopted in 1981, in 1989 they adopted an alternative method. That method provided funding to the parks through a graduated formula that started at \$0.50 up to \$1.00 since 1991/1992 per person for the jurisdiction. Mr. Flaiz stated that based on population provided them with a little less than \$94.000.00. This also provided funding to the Thompson, Chester and Russell Park districts. There was a brief discussion about Russell Township now having two park districts as a result of a break off from the original as a citizen's park. Under the original formula the Russell Park would be \$5,200 a year and split between the two parks, however the current formula says they each get \$5,200. Commissioner Lennon questioned whether the citizen park could even be considered a park with no land and the levy they attempted failed. Mr. Flaiz stated that under the statue Parks are not entitled, however under the alternative method approved they can be; thus, they are pulling money from the *Townships.* The new method they are proposing eliminates that \$1.00 per person for the parks. Mr. Lennon expressed concern over the Geauga Park District, to which Mr. Flaiz noted that the Park District had a cash carryover of \$6.6 million dollars with a \$17 million-dollar budget for this year.

Mr. Flaiz went on to the Townships explaining that in the formula they start with a base of \$15,000.00 and then based on population get additional funds. Hunting Valley which is mostly in Cuyahoga County has a population of 116, they currently receive \$16,000.00 from Geauga and \$8,000.00 from Cuyahoga County, the new alternative method awards per capita, so they would receive \$116.00, under the change that states "if they are not wholly in the county". Mr. Flaiz explained that the County remains intact at 38% then the remaining funds are formulated out, the new method gives townships additional funds, so those that have Parks would be able to decide if they are going to provide funding to them. Mr. Flaiz expressed that this method no longer means Townships are funding other Township parks. An example was given of Chester Township park was receiving \$10,000.00, the park loses that funding but the Township gains \$14,500.00 more, which could then provide funding to the park. Mr. Flaiz explained that this new alternative method provides smaller Townships with funding that they could really use.

# <u>PROSECUTOR / VICTIM WITNESS - VICTIM OF CRIME ACT (VOCA) AND STATE VICTIM</u> <u>ADVOCACY ACT (SVAA) 2021-2022 GRANT APPLICATION</u>

Victims Advocate Cindi Haycox Wellman explained that it's bleak and dismal in the grant world for the victims of crime. As we know the Department of Justice has been cutting funding and taking money away from the victims and putting more funding to the accused as a way to solve the problem, it will cause less victims to serve, but she isn't seeing any decrease. This year they changed the way they are handling the grant and were told the amount they could apply for. Ms. Haycox Wellman explained that from 2018 to 2019 she saw a 7% cut, from 2019 to 2020 there was a 26% cut and for this year 2021 she is seeing a 35% cut over what was awarded last year. Mr. Lennon asked her to explain her position, to which Ms. Haycox Wellman explained that she is a credentialed advocate, and she assists victims of felony level crimes, with her focus being on the Common Pleas Court and the Juvenile Court, and by Marcy's law they have to notify victims of crimes, guide them through the process, notify them of hearings, sentencing, to get restitution, notification of prisoner's release, bond, to keep them aware, compensation programs through the Attorney General's office, which includes therapy bills, crime scene cleanup, funeral expenses, along with assisting the victims with hospital testing, testimony, and through any hearings. Mr. Morgan explained that the Prosecutor's Office has been helpful in assisting her. Ms. Haycox Wellman explained that they are required to have a 20% match and is asking the Board to provide the match to keep her funding the same.
