# PERRY NUCLEAR POWER PLANT

Perry Nuclear Power Plant Senior Communications Representative Mandy Nagle and Geauga and Ashtabula County Liaison for Emergency Management Michael Vuyancih explained that they wanted to come and introduce themselves to the Board in case they ever have to work together. Mr. Lennon explained that we haven't been able to do actual drills, the one in 2020 was a virtual tabletop. Mr. Vuyvancih explained that in 2022 will be the big hostile action-based drill that includes all the Counties. Ms. Nagle explained that she started in October, replacing Wendy on the Nuclear side of communications, that they wanted to put faces with names. Mr. Dvorak inquired if they have ever been asked about why they never started the second unit. Ms. Nagle explained that it was only completed about sixty percent before they realized it would be too expensive to operate both. Mr. Dvorak stated that he worked on the plant pouring cement. Mr. Spidalieri asked about shoreline security barrier for boating, to which Mr. Vuvyancih

explained that most of the time they don't bother the fisherman, only if they start doing something weird or attempt to come on land and then they contact the Coastguard.

There was discussion about the plan and the training they do with the local fire departments and the Sheriff's Office regarding evacuation with the schools. There will be an Emergency Operations Center training on Friday, October 15, 2021.
