<u>COMMISSIONERS OFFICE – RESOLUTION – ACCEPTANCE APPROVING CARES ACT</u> <u>EXPENDITURES</u>

Mr. Gorton explained the CARES Act expenditures for today that include no reimbursements, they are just proposed expenditures for various departments, including for the County Engineer's Office PPE, touchless restroom conversions, four chainsaws, six snow plow trucks, a Ford 550 Quad Cab pickup truck, a mini excavator, 21 hand held radios and six laptops. Commissioner Lennon stated that he noted the amount for the County Engineer has dropped from last week of the original request, to which Mr. Gorton stated yes, the number of snow plow trucks dropped from ten down to six. Mr. Lennon inquired about how much a snow plow truck costs, to which Commissioner Dvorak stated about \$150,000.00. Mr. Lennon stated that he was confused on intent of the CARES Act funding to be used, and read from the CARES Act Coronavirus Relief fund usage, that it is for public health emergency, and that the expenses were not accounted for in the budget. Mr. Lennon stated that he has a hard time how a mini excavator relates to a public health emergency. Mr. Lennon stated that while it has been expressed that the Prosecutor and Auditor have approved these expenses as legal, but today we are here to say are these reasonable expenditures. Mr. Lennon stated that adding six trucks for rotation, when does it end, and while if it's not spent we have to give it back and someone else will spend it, and while he wants Geauga County to benefit, he personally doesn't feel this is right. Mr. Lennon stated that he needs additional reassurance that this is ok, to which Mr.

Gorton added that the Auditor's Office had reached out to the Office of Budget Management on these purchases and they have not received a response back yet, while we are not required to do this check, it helps when we are audited on these funds. Mr. Lennon expressed concern about adding equipment, it adds additional costs for insurance, personnel and maintenance, that there are ways to clean a vehicle. Mr. Gorton stated that depending on what the Board wants to approve today, we do have an alternative resolution that removes the trucks, excavator and chainsaws that brings the total down to just over \$307,000.00. Mr. Morgan stated that a concern is on whether the trucks would be delivered in time, to which it was noted that the Engineer confirmed they are in stock. Mr. Lennon expressed that while it is a great opportunity he just has to be honest with himself this purchase does not fit the expenditure. Mr. Dvorak added that his understanding of the process, the County Prosecutor and Auditor review the expenditure and ask any questions and give the approval, citing cross contamination as the reason. Mr. Dvorak stated that the drivers are in the trucks for 8-12 hours a day, and feels that we should capitalize on this and try to get the maximum we can. Mr. Gorton again stated that the response has not yet been received from the OBM. Mr. Lennon stated that if he was being asked, he says no. Mr. Gorton stated that if the OBM response is received and it is approved they could be added next week. Mr. Gorton stated that he was asking the Board to continue to move forward with the other items presented for expenditure for the other departments.

Clerk Christine Blair noted that the resolution being presented removed the snow plow trucks, the chainsaws, the mini excavator and pickup truck.

WHEREAS, the documents including the assertion of necessity memorandum have been reviewed by the Board for the Board to consider whether said funds can be expended to cover said costs;
