# <u>AUDITOR'S OFFICE – ADDRESS QUESTIONS</u>

Auditor Chuck Walder stated that he heard there was questions on the invoices that were paid by the order from the Writ of Mandamus. Mr. Walder expressed that he was not happy that the review by the Commissioners was removed, but there were five vendors included in the writ, and removed oversight of any judicial expenditures. Today on the financials you will see that items are being paid under protest, that ORC 319.16, and under protest the Auditor's liability is surrendered and reverts to Auditor of State. Mr. Lennon expressed that the old invoices never made it to this office, Mr. Walder stated that the ruling of the Supreme Court, stated that the law changed and the bills were being permitted under the change.

Prosecutor Jim Flaiz directed the Auditor to pay the bills, the Commissioners have the appropriation power, but they need to fund the departments under statutory duties. Mr. Dvorak expressed that it's a new change. Mr. Walder stated that this now affects everyone in the state, many Judges weighed in and the pressure point was applied, it's disappointing and now the tax payers are dealing with two standards now, check and balances and now the Judicial has a lower standard, than the current check and balance. Mr. Walder will continue to fight for what is right.

Mr. Gorton inquired about the items being stated to the Auditor of State, to which Mr. Walder stated that anything paid under protest is reported to the Auditor of State, submitting party and then it is posted on the Auditor's site so they can do a real time investigation, so they are posted on the public transparency page. Mr. Walder started this page so that oversight by the public is important.

*Mr.* Flaiz stated that bills will go through session, but will be noted as under protest. *Mr.* Walder stated that there was live and in session, live meant that oversight was not the authority of the Commissioners, Solid Waste is considered a live transaction, not a session transaction, the Court is funded by the Board, through the General Fund and other means, and now you no longer have veto power, so they will be paid, with no ability to stop payment. *Mr.* Walder stated that everyone should have a check and balance and be accountable since it's not our money, it's the people's money. *Mr.* Walder explained that change in the ORC 319.16, the burden shifts to the State Auditor, and expressed concern over that, and his worry, is that this process has less oversight. There will be no result on any item being sent until the Audit results next year. Standard Accounting practice legitimizes the purchase, or the Judge can say I want to do what I want. *Mr.* Walder explained the process done by the departments who spend something before an encumbrance is made, a Then and Now, this is no longer true for this one branch of government. *Mr.* Walder expressed concern over the process.

Resident Skip Claypool asked for clarification that a change in ORC 319.16, to which Mr. Walder explained that the lawsuit was filed, the law changed and then it was applied to the lawsuit. Mr. Walder added that they overruled an IRS rule for mileage that was overturned.

Prosecutor Jim Flaiz addressed the Board about the request for a supplemental of about \$135,000.00 that would allow them to install a different sprinkler system or provide for outside storage. Mr. Flaiz expressed that he had a feeling on where the Board was leaning, however, had the Board of Elections come to the Board two years ago about changes and not caused the Board to have already spent \$671,094.00 on changes to the Building there may be different feelings. Mr. Flaiz asked for a formal vote or feedback, to which Mr. Lennon expressed his opposition to the Attorney, and then agreed thinking this will be better for communication, and the only things coming back now are wants, we have exhausted way more and we can't keep throwing money at this. Mr. Flaiz discussed the storage and their space, and recommends that if the Board does reject it and he sent a letter to the Secretary of State, to explain everything that has been done, and invite him out to see the space and that this will be where they will be January 1<sup>st</sup>, and see if he can help intercede. The new space is so much better for voters, and for them with the space and the drop boxes, curb side voting, and is far superior to the current space they have now.

Mr. Lennon moved to reject the request.

Mr. Morgan explained that this in regards to the One Ohio committee and participation in the Region 13 governance structure with the opiate settlement. A portion of funding comes direct to the county, and then a portion comes to a region and then they determine how to spend the money. This was agreed to in the memorandum, our region is Lake, Ashtabula, Portage and Geauga. Each county will have 3 representatives, and then someone from each Region be a member of the State.

Mr. Lennon inquired how Mr. Dvorak was nominated, to which Mr. Dvorak explained that you have a direct connection to substance abuse. Mr. Flaiz noted that Ashtabula Commissioner has taken the lead and informally reached out to several members from each County. The Region has to set up the structure, 3 from each county, 1 incorporated, 1 unincorporated and 1 Commissioner. Clerk, Christine Blair noted that the resolutions from Ashtabula County showed that their Board had appointed persons to the One Ohio Board. Ms. Blair stated that I kept asking for answers from CCAO and they kept pointing us to the Clerk at Ashtabula. Mr. Lennon expressed his concern over whether Geauga will get our fair representation. Commissioner Spidalieri inquired if the committee is designed to choose where the funding will go, and you have different views on that, rehab, prosecution, law enforcement, and it can be a dangerous slope, with soft groups that make bad decisions. Mr. Spidalieri noted that opiate taskforce, drug dealers didn't want to be in Geauga County because we put the hammer down on them. Mr. Spidalieri expressed that we really need to focus on where the money goes, it will be short lived and gone. Mr. Flaiz stated that we have seen the value in the enforcement side, but originally the State was going to get it all and decide, the major portion will come to Geauga to decide on how it's used, but this Regional Board will have some local control.

Mr. Morgan stated that it was brought to our attention and the Counties were forming this region, and Mr. Dvorak sent the information to Mr. Flaiz and he expressed that Mr. Dvorak needed get it before the Board and get people appointed. There was brief discussion about possible people that could be appointed. Mr. Spidalieri expressed that the Board needs to agree on a direction for the funds as a Board to the Region.

WHEREAS, it is found that the regional governance structure as attached hereto as Exhibit A, ensures all Local Governments in this Region have input and equitable representation regarding regional decisions under The Memorandum; and

NOW THEREFORE BE IT RESOLVED, by the Board of Commissioners of Geauga County, Ohio, that:

Section 1. Subject to and effective upon the concurrence of all Local Governments (counties, incorporated and unincorporated areas) in Region 13, this legislative body hereby approves and enters into the regional governance agreement attached hereto as Exhibit A.

Section 2. It is found and determined that all formal actions of this legislative body relating to the adoption of this Resolution were adopted in an open meeting, and that all deliberations that resulted in such formal action by the Geauga County Board of Commissioners, were in meetings open to the public, in compliance with all legal requirements.

Section 3. This Resolution is hereby declared to be an emergency measure, necessary for the preservation of the public peace, health, welfare and safety. The reason for the emergency is to ensure prompt pursuit of funds to assist in abating the opioid epidemic throughout Ohio.

The Region 13 OneOhio Governance Board has agreed to the following governance structure: the board will consist of 12 members, 3 appointments from each Region 13 county, which will form the Region 13 OneOhio Governance Board, to include: 4 County Commissioners; 4 members representing the incorporated areas as nominated by their respective organizations/members; 4 members representing the unincorporated areas as nominated by their respective organizations/members.

The regional governance structure of Region 13 ensures all Local Governments in this Region have input and equitable representation regarding regional decisions under The Memorandum and such structure was discussed and agreed to by Ashtabula, Lake, Geauga and Portage counties at a meeting held on February 10, 2022.

The Ashtabula, Lake, Geauga and Portage counties enter into this Agreement which outlines Region 13's OneOhio Governance Board structure.
