<u>NAMI – STEPPING UP PROGRAM</u>

Mr. Lennon explained that he had met and discussed with NAMI Director Kim Carter about the Stepping Up program, which is a program that has a mission to help inmates with mental illness get clinical treatment. This is a statewide initiative and after discussing this program with the Sheriff feels we should look at moving forward with the program. Ms. Carter expressed that this is a National initiative that was started to address jails that were becoming mental health institutions. Ohio was chosen as one of five target states and retired Ohio Supreme Court Justice Evelyn Stratton is leading the Ohio project and is being done county by county. This project, once a county becomes registered, then NEOMED will come in and assemble a team across the county and does SIMS mapping which allows a deep survey into the county to review what services are being offered in the county and then propose projects we want to work on in the county and assists with finding funding for those programs. PEGS foundation in Hudson very heavily funds Stepping Up and like NAMI Ohio are very involved in the program. Ms. Carter stated that previously where she worked wanted to do a program just like this but couldn't get it off the ground.

Ms. Carter explained that is the Director of NAMI of Geauga, and that she has been involved with Mental Health issues since she was fifteen with family members including her own son, who has severely mental health issues and for the last nine years has gotten in trouble all over and currently, while homeless, is in jail in Washington D.C. for a crime he committed. Ms. Carter is a huge advocate for mental health and the work that she does, she is very passionate about and feels she is helping save lives including her own son.

Mr. Lennon expressed that what Ms. Carter is doing is very important and the mental health issues are on the rise in the jail and there are challenges when they arrive and how they are housed within in the jail. Mr. Dvorak added that he was very supportive of this program.

Ms. Carter explained that we need to be efficient and effective with what we already have available.

Sheriff Hildenbrand explained that this is a problem across the country, that there are no mental hospitals and the jail becomes that and the lack of treatment and follow up after they leave is a huge problem.
