PUBLIC COMMENT

Commissioner Spidalieri stated that they would not be offering Public Comment this year, however, is allowing a group that attended recent NOACA meetings choose two representatives to speak for five minutes each.

Local resident Walter "Skip" Claypool explained that recently NOACA held meetings at local libraries in each of the five counties to discuss a program regarding Climate Change and stated that between 50-100 people attended. Mr. Claypool expressed that residents are not happy with this and feel that the data they are using is bad science. Mr. Claypool stated that residents from five counties attended the Board of Directors meeting and were treated poorly. Lake County Commissioner John Plecnik asked the Board to allow the public to speak. Mr. Claypool asked the Board to ask their alternates to support the residents that are in attendance and allow them

to defend their case, adding that NOACA will not allow them to present, so that no one speaking can challenge the climate action plan they are presenting.

Jonathon Broadbent, resident of Newbury expressed that he can't touch the information that Mr. Claypool has, however feels that NOACA is another unelected body that is seeking to influence his life and the residents of Geauga County and that does not sit well with him. Mr. Broadbent expressed that the power and money that they (NOACA) exert is undue and does not represent the will of we the people and no ability to redress. Mr. Broadbent expressed that he wants to be given a chance to be heard.

Mr. Spidalieri stated that the Board pays dues to be a member and they work for their Constituents and offered the idea to maybe reach out to Ms. Galucci about having a meeting that would allow the residents to speak and be heard, but that it needed to be done in a respectful manner. Mr. Spidalieri stated that he would reach out to Commissioner Plecnik about Lake County being a part of the meeting. Mr. Spidalieri stated that even when Commissioner Lennon was President, we were a small voice in a big room. Mr. Spidalieri expressed that if she says no, then there is an answer.

Local resident Howard Newell made comment about NOACA getting involved in climate control in South Russell village. Local resident Katie Claypool inquired about if there was a number that if they put something together that would represent the opposition of the residents, to which Mr. Spidalieri noted that he did not have an answer to that. Munson resident Kristine Stenzel stated that if you went out and asked 100 people what NOACA was, 99 wouldn't know, so there needs to be education about what NOACA really is and suggests that getting a round table together to talk about what it is and represent both sides. Mr. Spidalieri stated that he would reach out to Lake County and see if something can be put together.
