Administrator Adam Litke presented the Board with some information regarding their services and budget for 2024 which includes what if's due to the new O&M program. Mr. Litke added that he also provided a copy of their 2022 Annual report. Mr. Litke stated that this is a renewal levy of .2 mill for five years. Commissioner Lennon asked what the total budget was, to which Mr. Litke stated it was around \$3 million depending on operation and maintenance, but fluctuates between \$2.5 and \$3 million adding that the majority of revenue is permit and inspection fees, which is expected at over \$1 million (former point of sale, now Operation and Maintenance). Mr. Litke noted that salary has gone down from previous years, but has expectations drop significantly. Expenses were expected to exceed Revenue however with the changes that were made, they are looking to break even, however, realistically it will take about two years to recover from the changes that get made. Mr. Litke explained that the levy is an important part of the revenue even with the agreement with Lake County.

Lake County Health Commissioner Rob Graham introduced himself to the Board as the Health Commissioner for Geauga Public Health and thanked them for their support of the Geauga Health District. Mr. Graham explained that they want to remain independent from the State, and a lot of the savings was in administrative and has kind of set a model for the state in the process. Mr. Lennon asked about where they were on the inspection fees for the business permit fees to be reimbursed. Mr. Litke stated that it will be a large hit to the cash carryover, however they are ready to do a contract with a company to do the reimbursements. There was discussion on

whether any of the inspections were being done, to which it was noted that it was mainly new construction. Mr. Litke asked the Board to approve the certificate of need, and it was noted that this is the first step in the process.

It is necessary to levy a tax in excess of the ten mill limitation for the benefit of the Geauga County Board of Mental Health and Recovery Services for the purpose of providing the Geauga County Board of Mental Health and Recovery Services with sufficient funds for the operation of mental health programs at a rate not exceeding seven tenths (.70) of one mill for each one dollar (\$1.00) of valuation, which amounts to nineteen dollars and no cents (\$19.00) for each one hundred thousand dollars (\$100,000.00) of the Auditor's appraised value valuation, for a period of five (5) years and which levy is a renewal of an existing levy of seven tenths (.70) of one mill. The tax shall be levied in tax year 2024 and begin collection in year 2025. The subdivision has territory affected in Geauga County.

Section 2. The question of levying additional taxes shall be submitted to the electors of said Geauga County and if passed the tax shall be levied upon the territory of Geauga County at the general election to be held at the usual voting place of Geauga County on November 7, 2023.

Section 3. Said levy shall be placed upon the tax list of the tax year 2024 <del>2023</del> if a majority of the electors voting thereon vote in favor thereof.

Section 4. The Board of Elections is hereby directed to submit the question of levying the tax pursuant to this resolution and Ohio Revised Code Sections 5705.221 and .25 to the electors of Geauga County at the general election to be held on November 7, 2023.

Section 5. The Clerk of the Board of Commissioners of Geauga County is directed to deliver a certified copy of this resolution to the Board of Elections not less than ninety (90) days before the general election to be held on November 7, 2023 and notify said Board of Elections to cause notice of elections on the question of levying said tax to be given as required by law.

#### <u>COMMISSIONERS' OFFICE – GROUP RETROSPECTIVE RATING PLAN</u>

Human Resources Administrator Kathleen Hostutler explained that the County has been a part of the CCAO Bureau of Workers Compensation Group Retrospective Rating Program and have been invited again to be part of the program, which is doing very well. Account Executive Todd Keserich is here today to provide an update on the program and how it's working for the county. Mr. Keserich provided an executive summary report which includes a six year look back on how claims are looked at. Mr. Keserch explained that claims, not just number but severity stay in your look back period for about five years and the County had some pretty severe claims that we are now beyond and are starting to see some beneficial numbers which results in better premium rates for the county. Mr. Keserisch stated that we have moved into a discounted rate for 2023 and projecting to continue for 2024 as we move forward.

*Mr.* Keserich explained that the group of counties are included in a group retro rating program that takes all numbers into one pot and at the end of the four-year lookback if they are good then counties will see premium refunded by the Bureau. This program has been in existence since 2010 and Geauga County has been involved since the beginning. Geauga County has received over \$1.4 million in premium refunds since being in the program. In 2018 and 2019 those years we hit the bump in the road with those severe claims and are starting to recover. Mr. Lennon inquired about payroll, to which Mr. Keserich stated that the premium is driven by payroll and the rate, and the counties rate fluctuates based on the Bureau's rate and the rate based on fluctuations, which helps explain that payroll isn't driving it, it's been stable. This is a fantastic program for the County be a part of and now there are 56 counties included in the program. Mr. Keserich briefly discussed that program when it got started in 2010 and the types of programs that are offered for the counties, the program is stable and has a good group of counties in the group but also statewide. Mr. Keserich stated that counties with larger populations participate in a different program or went self-insured. Every year we look at all the program.

*Mr.* Dvorak mentioned that he had been notified by the Auditor's Office that there was a transfer of \$275,000.00 to Transit and they had been making payments back, and as a Board we try and assist departments to continue to operate, there is about \$205,000.00 left, and that he had spoken with Mr. Kepple and that Laketran didn't need the funds, to which Mr. Dvorak added that he wanted the money back from Transit. Mr. Dvorak stated that Mr. Morgan can reach out to Mr. Kepple and he will reiterate what Mr. Dvorak stated and that he wants to start with a clean slate in the partnership. Mr. Morgan added that he would speak with Mr. Kepple and now that Ms. LaChapelle is back from vacation, he will also discuss the issue with her. Ms. Jones added that right in the agreement it states that Laketran will not bear any responsibility to any previous debts. Mr. Dvorak added that he feels that it aligns with what he is asking for, to get the \$205,000.00 back to the county. Mr. Morgan added that the addendum extended the time frame through the end of September for the final transfer of transit funds.

Gail Roussey from the League of Women Voters asked about the pay request for Donley's to which Mr. Morgan stated that it is for the office building punch list of remaining items that need completed, and with each payment a portion of retainage is held back until the final payment would be made once it is complete.
