#### AGRICULTURAL SOCIETY - FAIR BOARD UPDATE

Secretary Paul Harris came in to provide the Board with the annual Fair update. Mr. Harris explained that the fair never falls asleep, it's always moving now and that they are just 36 days away from the opening day, back to only five days this year. Mr. Harris noted that the Sea Lions were coming back this year along with nights of demolition derby, on Thursday and Saturday nights. Mr. Harris noted that the Natural Resource area took a hit during COVID, but this year will be back at 100% and it is the only one in the state and have extra fish coming this year. Mr. Harris explained that they have a fantastic crew and have two new Amish guys helping on the grounds crew, with 151 acres and 71 buildings there's a lot to work on and are able to pick and choose improvements, but they did put a new roof on the antique hall, new foundation by the arena, ramps and posts at the small grandstand which was surprised to discover rotting boards to they got them replaced, resided the First Aid building, about \$25,000.00 in electrical updates and LED lighting, including the midways, and a draft horse barn. Mr. Harris noted that there was some talk about the fountain, and the auxiliary decided to redo it this year.

Mr. Harris said that in a marketing standpoint, Geauga Fair is a leader in the industry with moving to electronic tickets and promotions on ticket sales and continue to run fiber out to the gates for the scanners to work better. They ran a flash sale and sold over 7300 tickets in four days.

Mr. Harris explained that the ground rentals are up and the calendar is full of events, noting that they just had a bike rally with over 1,000 bikes. Mr. Harris did say that while the grounds are open, and that people are on them every day enjoying the grounds, and of course with that comes continued vandalism, and is at an all-time high and they have seen a significant increase with the school next door. Mr. Harris added that they expanded the number of cameras and are now up to twelve and were able to catch one of the people doing the vandalism due to the cameras. They are still planning to do the multi-purpose building with 25,000 square feet, however funding is an issue, but that they did receive \$250,000.00 of funding from the state capital budget, but it will only be a scratch. Mr. Spidalieri asked about the total on the cost of the new building, to which it was noted about \$4 million or more. Mr. Harris explained that he wasn't going to get into the details, however the issues that they have had have tapped them out of extra funds.

Mr. Harris invited the Board to attend the Ohio Fair Managers Convention on January 5-7, 2024. Mr. Harris thanked Mr. Morgan for all his help with the issues that they have had, and he was a huge asset to them. Mr. Dvorak asked about their bid draw, being a derby or do they have a big-name entertainment, to which Mr. Harris explained that they did it last year with the Anniversary, however when the stands only seat 1800 and it costs \$80,000.00 to bring someone in, you can do that math, it doesn't work out. Mr. Harris noted that they do have Country Fest coming to the grounds in a couple weeks. Mr. Harris stated that the demo on Saturday will sell out and be sold out before fair even starts. Mr. Harris stated that advance sale tickets are currently \$8.00 for admission and are on sale now.

Mr. Spidalieri asked about the online bidding again for 4-H, to which Mr. Harris yes, that they would have Friday at 2:30 small and Saturday at 4:00 for large and it has been a huge option for the auction. It does include the add-on option for the kids. The option cost them \$3,500 however the kids got over \$15,000.00. Mr. Dvorak asked about the scholarship fund, to which

Mr. Harris stated that yes, it is also online and anything that comes in, everything goes out, and its \$1,000.00 per kid and usually is 5-10 kids that get them each year.

Mr. Spidalieri briefly explained that issue with the retaining pond and the flow onto the fairgrounds when it rains. Both sides are working towards a solution to get the issue resolved.

Skip Claypool stated that he wanted to talk about professional decorum and comments that have been in the paper by a Commissioner about the County Administrator and personnel at Water Resources. Mr. Claypool wanted to remind everyone that individuals are innocent until proven guilty, and that no comments that should be being made as they could impact the outcome, and asks the Board to refrain from making comments that would put your thumb on the scale that could tip it, and anything else is irresponsible. Mr. Claypool stated that we have great employees that have been here a long time and are due the respect to defend themselves.
