WHEREAS, Geauga County hereby recognizes the appointment of Scott Hildenbrand to the Region 13 OneOhio Governance Board to represent the incorporated areas located within Geauga County as nominated by members of the Geauga County incorporated areas, including the Village of Aquilla, Village of Burton, Village of Middlefield, City of Chardon and Village of South Russell; and

WHEREAS, terms of the members will be determined by the Region 13 OneOhio Governance Board; and

WHEREAS, the appointment to the incorporated areas of Geauga County to the Region 13 OneOhio Governance Board, is hereby recognized and appointed to serve on the Region 13 OneOhio Governance Board; now

THEREFORE, BE IT RESOLVED, by the Board of Commissioners of Geauga County, Ohio that the Board hereby accepts and appoints Scott Hildenbrand as member to the Region 13 One Ohio Governance Board, as outlined above.
