FIRST ENERGY, ENERGY HARBOR AND VISTRA

Emergency Response – Offsite Liaison Michael Vuyancih along with Senior Communications Representative Mandy Nagle from the Perry Nuclear Power Plant to discuss the integration of Vistra with Energy Harbor and the transfer of licenses. Ms. Nagle stated that they need the approval of four government agencies and so far, have approval from two. The transfer of the four licenses have been approved for transfer to Vistra, the FCC has approved the radios, we are waiting on approval from the Department of Justice and the Federal Energy Regulatory Commission. Vistra has requested the middle of October for those and we are waiting to get the 4th quarter of 2023 integration transition. Ms. Nagle stated that the license for Perry will expire at midnight on November 7, 2026 and are in the process of renewing the license for an additional twenty years, the application has been accepted and are reviewing the 2000 page application.

DEPARTMENT OF DEVELOPMENT (COMMUNITY & ECONOMIC) – NOTICE OF INTENT – OHIO DEPARTMENT OF DEVELOPMENT FOR DEMOLITION AND SITE REVITALIZATION AND BROWNFIELD REMEDIATION PROGRAMS – DESIGNATING COMMUNITY DEVELOPMENT AS LEAD ENTITY

Director Gina Hofstetter asked the Board to acknowledge a notice of intent that was submitted by the County Administrator designating Community and Economic Development as the Lead Entity for the Demolition and Site Revitalization and Brownfield Remediation Programs. Ms. Hofstetter stated we are engaging with the state and learning about what is available in regard to Brownfields. Mr. Morgan briefly explained that they provided a very short window of time to submit the notice of intent and submitting that did not commit the County to anything further other than to submit interest in the program. Ms. Hofstetter stated that they just released the program guidelines last night and will be attending a webinar on Monday. There are still a lot of unknowns about the program right now, but applications will be accepted through Community Development and request approval by the Board and then from the State on any projects. Mr. Morgan added that this first round may be publicly owned properties and not private, but once all the requirements come out we will know. Ms. Hofstetter stated that Townships and Communities will be notified and depending on guidelines we hope to get some good applications.

Mr. Swenson stated that over the course of the last few months, there has been some behaviors that have caused some concern and at the recommendation of the Prosecutor's office we feel it necessary to retire Kota Bear and discontinue having in the

interviews. Kota is a wonderful family dog and feel its best. Mr. Christopher explained that he does a fantastic job with the kids but doesn't get along well with other dogs. Mr. Swenson stated that Kota was purchased with VOCA funds and are following the correct process. Mr. Swenson stated that he has served the community well and down the road we may consider another puppy but with being short staffed, we will revisit down the road.

Director Jessica Boalt explained that House Bill 33 of the 135th General Assembly established a Healthy Aging Grant and the Ohio Department on Aging is making that grant available to each county, however, Commissioners must apply for it. Ms. Boalt stated that the purpose of the grant is for older Ohioans to keep them at home, connect to their community and promote a healthy active lifestyle. Ms. Boalt stated that Geauga County has been allocated \$201,575.86. Ms. Boalt stated that the grant can be used in the community as 20% Food Assistance, 20% Housing assistance, 10% Internet access and the rest towards the State's Plan on Aging goals. Ms. Boalt stated that should the Board submit for the grant, community partners would be able to apply for the food and housing portion of the grant. Ms. Boalt stated that notification of this grant came out on October 2nd and the deadline to apply is midnight on October 13th.

Ms. Boalt explained that she went onto the portal and in total it takes about ten minutes to apply and offered to assist in submitting that application. While \$200,000 doesn't sound like a lot, it's a lot that can help our seniors. The grant period is October 1, 2023 through September 30, 2024. There is a reporting process as well as an RFP process for agencies to apply for the funds. Ms. Boalt briefly explained who might be looking to apply for the food assistance like a pantry. Assistant County Administrator Linda Burhenne added that even applying for the funds doesn't commit the County. Ms. Boalt stated that any unused funds do get returned to the state.

ELIZA JENNINGS ACQUISITION OF THE WIELS

Attorney Gene Killeen explained that they were asking the Board to assist with tax exempt revenue bonds for the acquisition of The Wiels by Eliza Jennings from Montefiore Housing. Clerk Christine Blair explained that Mr. Killeen was here last week while Mr. Spidalieri was out to explain the conduit financing they are requesting. Ms. Blair stated that as part of the process a Hearing is required by the IRS and a resolution would need to be approved and documents that would need to be signed. Mr. Spidalieri asked for a brief explanation, to which Mr. Killeen

explained that tax exempt, 501C3 organizations are allowed to borrow at tax exempt rates and involves the local political subdivision to allow them to take advantage on the financing. Mr. Killeen stated that it is a single buyer of the bonds, a bank that already owns other Eliza Jennings debt, the federal tax rates and tax exempt rates are a difference of about 1% of the total which is about twenty million dollars. Mr. Spidalieri stated that the advantage for them is the savings, but what is the advantage for the County. Mr. Spidalieri asked the question of if the Board doesn't do this will they close, to which Mr. Killeen explained he wasn't sure. Mr. Killeen explained that it is beneficial to the area to maintain high quality care. Mr. Killeen stated that tax exempt organizations take advantage of tax-exempt financing and is an ordinary request, which is a benefit the IRS gives to tax exempt organizations. Mr. Spidalieri expressed that he would not be in support of it, organizations like this are profitable and owners need to make decisions on whether it makes sense to buy it. Mr. Killeen stated that there is very limited involvement, as it's really a transaction between a bank and a borrower and taking advantage of a tax benefit of being a 501C3. There is an issuer fee that goes to the County for the process. *Mr. Lennon stated that they are tax exempt as a 501C3, and there was already tax exempt* financing when the initial construction took place, the project has benefitted and understand this a purchase and new owner, however, agree with Mr. Spidalieri and lean towards no. I was told that there would be no impact on the county's rating but could have impact on our borrowing ability. Mr. Morgan stated in talking to Bond Counsel, that if there is a default the county is not obligated on the debt, however, there could be some impact on the county's rating. Mr. Killeen expressed that it could be with a public offering, however this is a private transaction. Mr. Lennon expressed that he could look at more of a new construction situation but not in an acquisition. Mr. Spidalieri thanked him for being there today. Mr. Killeen offered that Bond Counsel is available to answer any questions, however at this point is unsure in the process if they could move forward with the sale of The Wiels.

Mr. Morgan asked the Board to make a decision, suggesting making a positive motion to hold the public hearing as that would be the next step in the process and from the sounds of it would not move forward.
