# PUBLIC COMMENT / QUESTIONS

Diane Jones was inquiring about the item that was just approved regarding the request for review by the Prosecutor's Office for a contract with W B Mason, the purchase agreements and an engagement letter for Fishel Downey. The next action was to then authorize Mr. Morgan to execute the engagement letter for the policy review once it is received and certified.

Resident Lois Flynn from Hambden Township thanked the Board of Commissioners for the letter they sent out about the changes to the tax increase and that she contacted the office on what she needed to do and made those calls to reach out to the other entities. Mr. Spidalieri tried to explain the portion the Commissioners did to try and aid the taxpayers by suspending the collection of a .5 mill levy reducing the .7 mill levy for Job and Family Services to offset the portion the County would receive; they asked the Townships and the Schools Boards to consider doing the same action by reducing collection of the levy to offset the increases. Mr. Spidalieri noted that some Townships have taken action, however they are hearing that some of the Townships have done anything yet. Ms. Flynn added that it is up to the residents to request the city, townships, villages and schools to consider taking an action. Mr. Spidalieri briefly talked

about where property taxes go, to the voted-on levies and the small portion that the county operates on. Ms. Flynn thanked the Board for the explanation but added that voters should be taking a look at those with levies that may not be taking action and really need to consider how they vote when those levies are back on the ballot again. Discussion continued about those that will be receiving the extra taxes and those that are choosing to not take any action and will collect then that extra tax dollars. There was discussion about a newsletter going out to the residents to keep them informed about happenings in the county. Mr. Spidalieri noted that the Board are taxpayers too and felt it was important to take some kind of action. They briefly talked about following up on the letters that were sent out and consider putting a contact list of who to call.
