Mr. Spidalieri explained that during the process of the county office building, a review of the existing buildings were rated and many did not rate well. The original plan was to do the thirty-five acres, which could have been done in phases, but instead we built here, and now are looking at the expansion project at the Courthouse. Mr. Spidalieri stated that the Board was going to authorize Mr. Morgan the County Administrator to make a move towards purchasing the Chase Building on the square, and plan to take CASA at 470, Public Defender, Probation Department and eventually move the Treasurer's Office into the old Chase Bank area. Mr. Spidalieri stated that the second project is for the Department on Aging for the Senior Center and give authorization to move forward with the purchase of the old Dollar General. The property has seventeen acres which will give the Seniors have a nice, dedicated facility, but the area allows for walking trails, a retention basin with a pond, a pavilion which will give them the ability to take the services to a higher level. Mr. Spidalieri briefly talked about the renderings done by TDA on the old Dollar General building for the Senior Center and the timeline for moving forward and be able to move forward with the sale of the old 470 property. Mr. Spidalieri explained that while there will be upfront costs, however over time will exceed the price for purchase and build outs and the recapture of funds from the sale of other properties. Mr. Spidalieri continued by adding that the senior population is growing, and this will take the services they need to the next level.









Commissioner Lennon added that even before he became a commissioner, the idea has been to consolidate the buildings, and this will be more of a two-campus area option, these new properties give us flexibility for the future. Mr. Lennon added that working with the City of Chardon to get business in there to bring life to the City aside from County employees. Mr. Lennon noted that there was some other options on the square, but this was a much better option. Mr. Lennon expressed that the senior center project funding has been saved and included levy money that keeps additional costs off the taxpayers, but gives them the opportunity to continue with the ideas for phase II, that takes us long into the future.

Mr. Dvorak added that this has been being discussed for almost a year, and even during construction of the renovation of the Courthouse, there are departments that need to be relocated while that is happening, and we are trying to maneuver in the right way. Mr. Dvorak added that after hearing the proposed property for the senior center included seventeen acres and could include more than just the building and for a good price he feels the county will be moving forward in the right direction.

Diane Jones questioned a statement about the price per square foot, which it was noted that the cost for the office building was around \$400 per square foot, however until all the agreements are done, and they are able, they will disclose all the numbers.

Gail Roussey from the League of Women Voters inquired about the timing of the purchase, to which it was noted it would be within the month, she asked where the Opera House was, to which it was noted that the Treasurer's office is located there and she then inquired about where ADP would be located, to which it was noted that there would be room in the Chase Building, to which it was noted that they will have locations within both buildings.

Ms. Roussey asked about the Statutory Group meeting being on the agenda and now it has been removed, and it was discussed that the members of the group not being able to attend on that day and time. It will be scheduled and held, we just haven't figured out a date and time yet. This is a requirement of the ORC for Courthouse construction and includes the Commissioners, Sheriff, Judges of Common Pleas, Probate and the Clerk of Courts.
