There was a brief discussion about bed tax coming back up since COVID. Mr. Lennon added that maybe someday we will have a hotel in Geauga County that will help.

### <u>COMMISSIONERS' OFFICE – AGREEMENT – MKDF ENTERPRISES, LLC D.B.A.</u> HEALTHWORKS – PERFORM SCREENINGS

Human Resources Specialist Kelly Bidlack explained that in the past CEBCO has paid for the onsite healthcare screenings for employees on our healthcare plan and this year they are not doing that. Ms. Bidlack asked the Board to approve an agreement with MKDF Enterprises, LLC d.b.a. Healthworks to handle the screenings for this year and will paid for using Wellness Grant funds.
